Plaintiffs as their claims allege:

I. Introduction and Summary

1. Plaintiffs bring this case as a Class Action on behalf of all school children, grades K through 12, of the State of Idaho, and on behalf of their parents and guardians, to enforce the provision of Article IX, Section 1 of the Constitution of the State of Idaho which reads as follows:

§ 1. Legislature to establish system of free public schools.

The stability of a republican form of government depending mainly upon the intelligence of the people, it shall be the duty of the legislature of Idaho, to

establish and maintain a general, uniform, and thorough system of public, **free** common schools. (Emphasis supplied.)

2. In contravention of the constitutional requirement to provide free common schools, the great majority of Idaho's school districts, being grossly underfunded by the State Legislature, have been engaging in the practice of levying fees upon the students and their families for various supplies and coursework, elective and otherwise, in violation of the Idaho Constitution.

3. Idaho stands ranked as the lowest state in the nation in terms of per capita funding of its schools. That fact does not arise from necessity. The history is that the people of Idaho strongly supported the institution of the Sales and Use Tax in 1965 primarily for the purpose of adequately funding Education. At that time, the Sales and Use Tax contained only 17 exemptions, which exemptions were there for the purpose of exempting sales prior to "sales at retail," (thus distinguishing it from a "value added" tax).

4. Year after year the Legislature has added new exemptions to the Sales and Use Tax, to the point where there are now 89 exemptions, with the result that the exemptions have a value of approximately \$1.7 Billion, whereas the tax itself as now imposed provides the State with only \$1 Billion in revenue. The result has been to impose increased burdens on school districts at a time when limitations upon local taxing authority make it impossible for the school districts to provide free public schools as required by the Idaho Constitution.^{1 2}

¹ Plaintiffs reluctantly bring this action to require that the school districts refund unconstitutional fee charges against the students and their families, but do so with the understanding that the Legislature can remedy the situation by restoring the Sales Tax base and reimburse the school districts for any fees returned to the students through a supplemental appropriation in the 2013 Legislative session.

² The Idaho Supreme Court, in *Idaho Schools for Equal Opportunity v. State of Idaho* (Dec. 2005) entered Judgment that the then present system of funding schools was deficient to meet the constitutional mandate required of the Legislature. Now, seven years later, the Legislature has taken no corrective

5. The Idaho Supreme Court, in *Paulson v. Minidoka County School District No. 331, et al.*, 93 Idaho 469; 463 P.2d 935 (1970) ruled that the levying of certain fees upon the students violated the constitutional mandate, the Court ruling in part:

- “Because the Appellants’ [Minidoka County School District No. 331] High School is a ‘common school,’ it must, by constitutional command, be ‘free.’”
- One-half of the \$25 fee is assigned as a payment for what Appellants themselves call extra-curricular activities. If a student of Minidoka County High School wishes a transcript of his scholastic achievement he must pay the entire \$25, one-half which is expressly consigned to fund extra-curricular activities. Items which are “extra-curricular” are, by definition outside of or in addition to the regular academic courses or curriculum of a school. A levy for such purposes, imposed generally on all students whether they participate in extra-curricular activities or not, becomes a charge on attendance at the school. **Such a charge contravenes the constitutional mandate that the school be free.** (Emphasis supplied.)
- Textbook fees...are indistinguishable from other fixed educational expense items such a school building maintenance or teachers’ salaries. The Appellants may not charge students for such items because the common schools are to be “free” as our constitution requires.
- (Paraphrased) The Court held that a charge for transcripts was a necessary part of the “entire product to be received by the student” and it must be “free,” and that the school could not withhold a student’s transcript to coerce payment of the lump sum \$25 fee.

6. Idaho Code § 33-603 **unconstitutionally** provides in part as follows:

Payment of fees or returning of property. The board of trustees of each school district shall have the power and the ability to require as a condition of graduation, as a condition of issuance of a diploma or a certification, or as a condition for issuance of a transcript, that any and all indebtedness incurred by the person when he/she was a student be satisfied, or that all books or other instructional material, uniforms, athletic equipment, advances on loans, or other personal property of the school district borrowed by the person when he was a student of the district, be returned... (I.C., 33-603, as amended by S.L. 1992, ch. 112, §1; S.L. 1996, ch. 138, §1)

action, and in fact, during that period, other statutes have further debased funding for Idaho’s schools.

7. Plaintiffs, through this action, seek a Declaratory Judgment and other relief from the current fee imposition practices.

8. Plaintiffs are subjected to variety of communications under the imprimatur of state actors, including Defendant School Districts, requiring the payment of fees for enrolling in public schools as a part of the student registration process. Such communications include but are not limited to statements in Registration Materials, Fee Payment links on Defendant websites, fee announcements by school administrators and teachers, inclusion of required fees in Student Handbooks, and school board policy, all of which compel Plaintiffs to pay fees that contravene the constitutional protection of a free public education and which amount to a form of state coercion of Plaintiffs to pay for essential elements of a free public education. Such state action is impermissible establishment of fees under the Idaho Constitution Article IX, Section 1.

9. Defendants also communicate under the imprimatur of state actors, the expectation that Plaintiffs will purchase and provide for the Defendants school supplies which are not specifically attached to Plaintiff student needs, a requirement that, even though described at times as voluntary is clearly communicated as being a requirement for the Plaintiffs to enroll children in school, successfully attend, and complete school assignments. Plaintiffs cannot distinguish supply list purchases from fees and Plaintiffs cannot, therefore, jeopardize attendance at school in order to avoid unwanted exposure to unfavorable notice by or criticism from Defendants state actors—school teachers and administrators. Under the imprimatur of Defendant School Districts, Defendants have created a state-sponsored and state-directed “essential consumable supply curriculum” which Plaintiffs fund that contravenes the constitutional protection of a free public

education and which amounts to a form of state coercion of Plaintiffs to pay for essential elements of a free public education. Such state action is impermissible establishment of fees under the Idaho Constitution Article IX, Section 1.

10. A reasonable observer would believe that payment of fees and purchasing of essential school supplies signified constitutionally protected action by Defendants. But the State may not place the dissenter in the dilemma of either paying or protesting fees and “essential school supply lists”. This is especially true at the middle school and high school level where adolescent students are often susceptible to peer pressure, especially in matters of social convention. Through its pervasive control of communicating and endorsing its fee and school supplies list, Defendants have created an environment that feeds on social pressure to enforce payment of fees and providing of “essential school supplies”. The embarrassment and intrusion of this exercise cannot be refuted by arguing that the fees are of a *de minimis* character, since fees control student choice of elective and advanced courses that are important to the student’s overall learning and potential for continued education. It also gives insufficient recognition to the real conflict of conscience faced by an adolescent student and financially limited parents and guardians who would have to choose whether to enroll in a class like Chemistry or take a less rigorous class. Nor is the “essential school supplies list” *de minimis* and voluntary, given the environment created by Defendants and the clear message to Plaintiffs that failure to purchase “essential school supplies” will compromise not only their children’s learning, but the entire school’s instructional effectiveness. It is an affront to Plaintiffs and a violation of the Plaintiffs rights under the Idaho Constitution’s guarantee of a free public education.

11. The pressure, though subtle and indirect, to pay fees and purchase “essential school

supplies” that become part of the Defendants’ general education curriculum program can be as real as any overt compulsion. The State cannot require one of its citizens to forfeit his or her rights and benefits to a free public education as the price of resisting conformance to state-sponsored school fees and purchasing of “essential school supplies” that will be distributed to and used by all students, a burden that is constitutionally required to be provided by the Defendants.

II. Jurisdiction and Venue

12. Jurisdiction lies in this court under Article IX, Section 1 of the Constitution of the State of Idaho. Venue lies in this court for actions against the “state” defendants and as the most convenient forum for litigation against the Defendant School Districts.

III. Parties

(A) Parties Plaintiff:

1. Russell Joki is a long time professional educator at the K-12 and higher education levels, for the twelve years last past as a professor in the Graduate Studies Program of the College of Education at one of Idaho’s major universities, and is the legal guardian of Peyton Lee Gifford-Joki, a current student at Meridian High School.
2. Kathleen Joki is a former middle school and pre-school educator, and grandmother of Peyton Lee Gifford-Joki.
3. Sarah Holt is a former pre-school educator and homemaker and is the mother of Sabrina Holt and Sophia Holt, each currently enrolled in Kindergarten at Chief Joseph Elementary in the Meridian School District.
4. Plaintiffs Vikki Ascuena; Daniel Brainard; Don And Patti Coffman; Anne Comstock;

Sheryl Henley; Scott and Kristi Henley; Rodney C. Joki; Joe and Maralyn Murdock; Connie Pulambo; Eric and Aimee Schooley; Kathy Vilendrer, (Grandparents of Enrolled School Children in the cities of Kooskia, Kellogg, Coeur d'Alene, Meridian and Boise, and each are citizens of Idaho and patrons of the School Districts in which they reside and have an interest as citizens and patrons in the quality of education in Idaho.

(B) Parties Defendant:

THE STATE OF IDAHO; THE HONORABLE TOM LUNA, Superintendent of Public Instruction; the IDAHO STATE DEPARTMENT OF EDUCATION; and the IDAHO STATE LEGISLATURE. Each of the foregoing Defendants are charged under the Constitution and the laws of the State of Idaho with the proper administration of Idaho's schools in grades K through 12 and have varying responsibilities relative to the appropriation and utilization of public funds for the use and benefit of the schools and the patrons thereof.

The DEFENDANT SCHOOL DISTRICTS listed in the caption of this Complaint are each made Defendants herein by virtue of being charged with the administration of their respective school districts and the proper and constitutional use of funds whether procured via appropriation from the Idaho Legislature, local tax levies, federal In-Lieu Grants or distributions, or otherwise.

IV. Class Allegations

13. This action is brought as a Plaintiff class action pursuant to Rule 23(b)(3) of the Idaho Rules of Civil Procedure.

14. Plaintiffs and Class Representatives Russell Joki, Kathleen Joki, Peyton Lee Gifford-Joki, Sarah C. Holt, Sabrina Holt, Sophia Holt and the other named Plaintiffs are

members of the Plaintiff Class as defined herein and bring this action on their own behalf and on behalf of those similarly situated.

15. Plaintiffs seek to recover damages which they, and the Class Members, have suffered, and continue to suffer, as a result of the conduct and practices of the Defendant School Districts in charging various fees for educational services in grades K-12 in violation of the Idaho Constitution's mandate to provide free, common schools.

16. The class represented by the Plaintiffs (the "Plaintiff Class") includes all students now, and in the future during the pendency of this action, enrolled in the Defendant School Districts together with their parents or guardians.

17. The named Plaintiffs are members of the Plaintiff Class.

18. There are currently more than 280,000 school children who are members of the class and literally thousands of their parents and guardians, making the members of the Plaintiff Class so numerous that joinder of all members is impracticable.

19. The claims of the named Plaintiffs are typical of the claims of the members of the Plaintiff Class. Plaintiffs and all members of the Plaintiff Class sustained economic and as a result of the Defendants' wrongful and unconstitutional misconduct complained of herein.

20. Plaintiffs will fairly and adequately protect the interests of the members of the Plaintiff Class at each resort and have retained counsel competent and experienced in class action litigation as well as prosecution of actions of this nature.

21. A class action is superior to other available methods for a fair and efficient adjudication of this controversy. Since the damages suffered by the individual Plaintiff Class Members may be relatively small and geographically diverse, the expense and burden of

individual litigation makes it impossible for the Plaintiff Class Members individually to seek redress for the wrongful conduct alleged.

22. Common questions of law and fact exist as to all members of the Plaintiff Class, which predominate over questions affecting solely individual members of the class.

23. Plaintiffs know of no difficulty which will be encountered in the management of this litigation which would preclude its maintenance as a Plaintiff Class action.

24. Among the questions of law and fact common to the Plaintiff Class are:

- (a) The proper interpretation of the constitutional mandate for “free” schools;
- (b) The types of fees which are impermissible under Article IX, Section 1;
- (c) Whether the fees wrongfully charged must be refunded;
- (d) The terms of a Declaratory Judgment;
- (e) Whether Idaho Code Section 33-603 should be declared unconstitutional to the extent it conflicts with the mandate of Article IX, Section 1.

IV. Factual allegations

25. Appendix A hereto, (which contains a sampling of listings on web-sites of Idaho schools of fees charged to students), demonstrates the generally pervasive proclivity of School Districts throughout the state to impose fees upon students in violation of both Article IX, Section 1 of the Idaho Constitution and the ruling of the Idaho Supreme Court in *Paulson v. Minidoka County School District No. 331, et al.*, 93 Idaho 469; 463 P.2d 935 (1970).

26. In August of 2012, the named plaintiffs, Russell Joki, Katherine Joki, and Sarah Holt attended school registration for the purpose of enrolling a high school student at Meridian High School and an Open House at Chief Joseph Elementary School of the Meridian School District No. 2 for enrollment and attendance of kindergarten students.

27. At the high school registration and Open House event, the Meridian School

District, a sub-division of the State of Idaho and under the policy jurisdiction of the Idaho State Board of Education, distributed copies of fee schedules, specifying amounts required to register for attendance at classes which, under the Idaho Constitution Article IX, Section 1 (Idaho Const. Art. IX, Sec. 1), should be part of a free public education.

28. Plaintiffs Joki paid \$85.00 in fees for their high school student for the purpose of registration as a junior and courses, a violation of the Idaho Constitutional provisions of a free education and *Paulson v Minidoka*:

29. Plaintiffs Joki paid \$90.00 for their kindergarten students for the purpose of “field trip, school supplies and milk for snacks, and art supplies” all of which should be included in the Idaho Constitutional provisions of a free education.

30. Plaintiffs received a handout from the kindergarten teacher, titled Chief Joseph Elementary School Supply List 2012-2013 which required educational supply materials and heard the kindergarten teacher indicate fees for attendance were due immediately.

31. Defendant school district, Meridian School District No. 2, includes on its webpage a link entitled “Pay High School Fees online.”

32. Plaintiffs allege that the fees collected in violation of the constitutional mandate by the Defendant School Districts throughout the state of Idaho exceeds \$2,378,482, as per the calculation on Appendix B attached hereto. This calculation is subject to modification upon

completion of discovery.

33. Plaintiffs request the Defendant School Districts, or alternatively, the Defendant Legislature of the State of Idaho, through a special appropriation, be required to reimburse each class member for fees unconstitutionally collected for the 2012-2013 school year.

VI. Attorney Fees under Private Attorney General Doctrine or Common Fund Doctrine.

34. Plaintiffs request the Defendant School Districts, or the Idaho Legislature, be required to pay their attorney reasonable attorney fees under the Private Attorney General Doctrine or the Common Fund Doctrine equal to not less than twenty percent (20%) of the fees ordered refunded.

WHEREFORE, Plaintiffs pray judgment as follows:

1. Certification this action as a Class action;
2. Declaring that certain of the fees being imposed by the Defendants upon school children and their parents and guardians for a public education are illegal and unconstitutional;
3. That the Defendant Idaho State Legislature or the Defendant School Districts be required to reimburse all Class Members for all such fees paid for the 2012-2013 school year, which sum is estimated to be \$2,378,482.
4. For reasonable attorney fees.
5. For such other and further relief as may be meet and equitable in the premises.
